

General Conditions and Rules for Participation

 The organizer of sports competition under the name CHALLENGEPRAGUE and all side events on July 26-27th, 2019 in Prague are companies: TRI Prague, s.r.o ID: 03914828 (info@challenge-prague.com), Challenge Family GmbH HRB 5355 and Česká Triatlonová Asociace, z.s. ID: 44851782.

2. The race is restricted to persons:

- a. older than 18 years who have reached the age of majority by the day preceding the day of the contest or a person older than 15 years who have reached the age at least the day preceding the day of the race and only on the basis of delivered document to the organizer, the written legal guardian consent of the participation, all the risks associated with it and with the approval of the terms and rules of the CHALLENGEPRAGUE.
- b. which duly registered and the registration fee has been paid on time.
- c. which picked up their starting package on time and during the race have on their chest/bike/helmet visibly placed a starting number with the chip assigned by organizer.
- 3. Any person who has registered to the race through the registration system or by registering on the spot and / or actively entering the race automatically becomes a participant (i.e. taking over the starting package and taking part in the race)

4. Each participant declares:

- a. that joins the CHALLENGEPRAGUE voluntarily and on the basis of a responsible decision.
- b. that is participating in the CHALLENGEPRAGUE at the own risk with regard to his or her own health.
- c. that is aware of the risk and danger of causing damage or injury resulting from participation in the race.
- d. that is legally fully insured for any accident, medical treatment or hospitalization. It is mandatory to have travel insurance which fully covers all sport risk in case of non-citizens of the Czech Republic or doesn't have public full healthcare insurance of the Czech Republic.
- e. that agree with providing the first aid or any other medical treatment to him/her.
- f. knowingly and voluntarily gives its consent to the processing of the personal data (photo/video with his or her face included) to the needs of the CHALLENGEPRAGUE and for marketing purposes of organizer of the contest:
 - i. By filling out and sending the registration form I grant permission to Controllers companies TRI Prague, s.r.o ID: 03914828, Challenge Family GmbH HRB 5355 and Česká Triatlonová Asociace, z.s. IČ: 44851782, as the organiser and to the third parties (hereinafter referred to as the



"Processors") such as Asociace Samaritanů ČR (providing medical service), Sportsoft (providing timekeeping) and Marathon-Photos.com (providing personalised photos sending by email) in accordance with the relevant regulations of EU so called GDPR No. 2016/679 and of Act No. 101/2000 of Coll. in its valid reading, to use my personal data such as name, phone number and email address, photos or videos with participant's face. etc., namely for business and marketing purposes and also for the purpose of sending information about the race.

- ii. I grant permission to the Controllers and Processors, in accordance with the relevant regulations to process my personal data listed in this registration form, for the purpose of verifying my valid participation in a sporting event (competition) and for other business and marketing purposes, all that for the time of ten years and also to publish my personal data in the media and on the websites or on social media. I am providing the permission voluntarily.
- iii. I have the right to withdraw my consent sent to the email or post address of organizers. A withdrawal of consent comes into effect on the moment of delivery and results in my exclusion from further participation in the competition for which I have registered except withdrawal of consent with sending marketing purposes which doesn't have impact to the participation.
- iv. All data will be processed and protected in accordance with the relevant regulations of EC so called GDPR by using active and passive security tools to protect especially name, date of birth, email, address, gender, phone number or medical information). The consent is valid for 10 years. Data will be deleted after this period.
- g. that is obligated to report all cases of theft or damage by third parties to the Police of the Czech Republic for further investigation (it is not possible to claim compensation from the insurance company without a protocol of theft or damage from the police).
- h. that is obliged to observe specifics of the Czech Triathlon Association race rules.
- i. that he is aware of all the risks and specifics of the race and its routes.

5. Organizer reserves the right:

- a. for change or correction of errors in the program or the conditions of participation in the race without prior notice.
- b. so use all photo and video material from the race included participant's face without any refund to this participant.
- c. the cancellation, change of distances, termination or amendment of the contest without any refund of the registration fee to participants in the case that it will not be possible for serious reasons to carry on, or manage to finish it as planned (e.g. crash on communication, protocol events in the city of Prague, extreme weather conditions, etc.).
- d. disqualify or exclude such participant who violates or does not comply with these General Conditions and Rules



- e. for Participation and / or is under the influence of narcotic drugs and / or provide false data during registration and / or the starting number does not belong to his / her person (it also applies to all handover or resale numbers).
- 6. Race will be held under any weather conditions, except extreme cases threatening the safety of participants, the result may be to transfer the start of the race, change distances or order of disciplines or/and its complete cancellation without any refund of the registration fee.
- 7. Organizer is not responsible for any personal injury, property damage, theft of property or other harm arising in connection with participation in the race or watching.
- 8. The organizer is not obliged to pay or refund any expenses for treatment or hospitalization. The participant is obliged to have the appropriate insurance for those purposes.
- 9. The organizer is not responsible for the loss of the participant's personal belongings during the race.
- 10. None of the organizer's decision is subject to judicial review.
- 11. Registration for the CHALLENGEPRAGUE is possible only electronically (by credit/payment card or invoice) via the on-line registration form primarily available from the website www.challenge-prague.com.
- 12. Organizer reserves the right to interrupt, complete cancellation or early termination of registration for the contest without prior notification or fulfilment of the announced capacity.
- 13. The capacity of the CHALLENGEPRAGUE and all side events are limited to a maximum number of participants up to 2.000 or less people in total.
- 14. Current amount of the registration fee, its graduation and a content of starting package are always available on the website of the organizer www.challenge-prague.com and during the registration process.
- 15. Registration is considered valid and completed after the payment, when the payment of the entire amount is credited to the account of the organizer.
- 16. Registration fee confirmed by participant in an order is final and non-refundable under any circumstances, even in the case of illness of the participant. However, participant can buy a Cancellation Option during registration process then he/she is allowed to ask for refund starting fee (not additional services or materials, bank fees can be reduced) according this scheme:
 - a. Usage
 - i. before April 1st 100% return
 - ii. between April 1st and July 1st 50% return
 - iii. between July 1st and July 25th 20% return
 - iv. No refund possible after July 25th doesn't matter a reason (no matter if medical, personal etc.)
 - b. If you wish to withdraw from FORD CHALLENGEPRAGUE please write an email to info@challenge-prague.com Please include your IBAN, BIC number, account holder name, bank name and bank address.
- 17. To change your registration including name and other ID please use sent your email to info@challenge-prague.com but not later than 60 days before the race starts.
- 18. Participant, which will be (based on legitimate requirement) allowed transcript registration including transfer the registration fee to alternate, acknowledges its



obligation to familiarize him/her with all the rules and conditions of participation in the race and furthermore about the consent to the processing of personal data. The alternating participant with his/her voluntary and informed consent (granted by participant to register for the race and / or their direct participation in the CHALLENGEPRAGUE), confirms the acceptance of all the terms and conditions (including consent to the processing of personal data) and is obliged to abide them.

- 19. Registration orders not paid immediately during creation or 5 day from the creation date of invoice are automatically cancelled.
- 20. Re-selling or transfer of registration or promo codes to another person is prohibited and can caused cancellation of the registration without any refund.
- 21. It isn't possible to transfer or sell promo codes. Promo codes doesn't make any guaranty of available registration slots.
- 22. On-line registration may be closed without prior notice, at the discretion of the organizer or in the case of capacity fulfilment.
- 23. If the capacity of the CHALLENGEPRAGUE will not be filled before the closing of the online registration down, the organizer may decide how to register participants directly at the start site on the day of the contest in the allotted time.
- 24. The starting package can be picked up in person before the race in a certain time, specified by the organizer at www.challenge-prague.com published on the site.
- 25. Starting packages can be picked up no later than the day of the race, in a time and place designated by the organizer. Later or in another place the packages cannot be picked up.
- 26. The package includes a T-shirt. The choice of your right size is limited in time, after this time will not be possible to choose the size and you will get the shirt size currently available at the finish spot in case you ordered it.
- 27. The organizer is entitled due to safety of participants at the starting line divide the starting participants into sub-sections and start in waves. The waves will be divided according to the age group.
- 28. Hospital treatment or hospital stay is not included in the starting package. The organizer provides only free first aid, so-called primary pre-hospital care.
- 29. Relay teams within CHALLENGEPRAGUE RELAYS can have two or three members. One member can't participate in two one by one disciplines in case 2 members relays.
- 30. Electric bikes, time trial bikes, and aerodynamic or special triathlon helmets are not allowed in TRY-ATHLON race/category.

31. Each participant is required to:

- a. comply strictly with the instructions published before the race on www.challenge-prague.com information sent via email to participants, presented during a race briefing or spoken word guidance forwarded by the moderator before the race.
- b. proof his or her identity when picking up the starting package by the email associated with the starting number or proof of identity card (picture ID, passport, driving license) which are of the same data as in the order (in the registry system).
- c. attend the race in person, representation without the prior consent of organizer, respectively transcription registration, is not allowed.



- d. follow the instructions of the organizer, volunteers, members of the Emergency Services and members of the Armed Forces even if it would mean to interrupt the race or abandon the course.
- e. observe the ban of other risky behaviour in areas along the route, where such conduct is prohibited for safety reasons.
- f. observe the rules of road and water traffic and consider that there may be vehicles, pedestrians or vessels on the race courses.
- 32. The time limit to complete the CHALLENGEPRAGUE MIDDLE / RELAYS is 7 hours from the start of the last wave, the CHALLENGEPRAGUE TRY-ATHLON is 1,5 hours. Participants going slower than average pace for the race time limit may be excluded from the race by organizer.
- 33. The ranking of participants in the result list is determined according to their order as they finish the race, it means according to the official chip timer.
- 34. The results (except penalties (only up to 15mins after finish)) can be complained not later than 5 days after the race and only electronically sent to the email address info@challenge-prague.com. The decision on the recognition of the claim is the exclusive right of the organizer.
- 35. The main competition pro-athletes and age groups are fully according to CHALLENGEFAMILY ranking rules.
- 36. The race is held under the Czech Triathlon Association rules which are according to ITU/ETU rules with specific exceptions listed on the event website.
